

Our Focus

he Nutrition Education Program works in all 120 counties to improve the lives of limited-resource Kentuckians through education and changes in behavior and in community. Through the Supplemental Nutrition Assistance Program Education (SNAP-Ed) and the Expanded Food and Nutrition Education Program (EFNEP), the University of Kentucky Cooperative Extension Service has agents and nutrition assistants across the state who are dedicated to improving lives in their communities.



Our Challenge

Poverty

In Kentucky, household median income is \$46,659, which is much lower than the U.S. median of \$57,617. Kentucky has high rates of poverty and food insecurity when compared to the United States as a whole.

In 2014, an estimated **2,292** Lee County residents lived in poverty, and **632** of them were children. This is a **-2.1%** decrease in total poverty and **-4.0%** decrease in child poverty since 2007.²

SNAP benefits

Participation in the SNAP program among those who are eligible for its benefits is higher in Kentucky than in the U.S. as a whole.¹

In 2015, **2,5**77 Lee County residents received SNAP benefits, a **20.9**% increase since 2007.³

Obesity

Nearly half of all American adults experience one or more preventable, diet-related chronic conditions, such as high blood pressure, cardiovascular disease, type 2 diabetes, and obesity. Kentucky has a high prevalence of hypertension, diabetes, and obesity, ranking in the top 10 when compared to other states. A large body of evidence shows that healthy eating habits and regular physical activity can help people achieve and maintain good health and reduce the risk of chronic disease throughout life.

In 2013, **2,042** Lee County residents were considered obese, representing **33.9% (27.9%-40.6%)** of the county's population.⁶

Our Solution

Provide hands-on, nutrition education to limited-resource audiences, focusing on:

- Buying and preparing healthy foods
- Developing new meal planning and cooking skills
- Adopting new healthy lifestyle behaviors
- Managing SNAP resources

In 2017, **1,205** Lee County residents with limited resources participated in nutrition education lessons.

Our Results

IN KENTUCKY

Lifestyle improvements

In 2017, 98% of adult participants made a positive change in food group choices and 81% showed improvement in one or more food safety practices. In addition, 71% began to plan meals in advance more often and 73% used the "Nutrition Facts" on food labels to make food choices more often. Youth participants also experienced behavior changes, with 85% improving their ability to choose healthy foods.

Our Success

Cooking camp helps youth gain confidence in the kitchen

early 20% of Kentucky youth ages 10 to 17 are obese, placing Kentucky 8th in the nation in terms of childhood obesity. Recent research indicates that when kids are involved in preparing and cooking their own meals, they are more likely to choose healthier foods. This year, the Lee County 4-H and SNAP-Ed programs collaborated on a cooking camp for youth age 9 and up. During the camp, kids learned various kitchen skills, such as how to hold a knife, how to chop, mince and dice, and the proper way to measure ingredients. Through the 4-H Etiquette KICKS curriculum they learned table manners. As a culminating event, students prepared an entire meal from scratch for their parents and guardians. Their menu included salad on a stick with herb dressing, one-pot spaghetti and fruit salad parfaits. The students set the table properly and served their guests as they arrived. Program evaluations showed that the students became more knowledgeable of nutrition, proper etiquette, knife skills, kitchen safety, hygiene and food safety.
